RELATIONSHIPS SEXUAL HEALTH & PARENTHOOD (RSHP):

A GUIDE FOR PARENTS



ABOUT

There is a growing secularisation of society in Scotland today. One of the consequences of this is that Christian parents, pupils, and teachers face many challenges in schools as the education system becomes more secular. This guide is designed to offer guidance and support on:

>>>> parental rights

signposting where more details can be accessed in relation to curriculum content around Relationships, Sexual Health, and Parenting ('RSHP')

informing parents how to access advice and support

It is important to remember that all schools should be keen to support effective partnership working between pupils, parents, and school staff.



PARENTAL RIGHTS

1. Equality law requires schools to protect, not promote, certain beliefs or faiths. They must not discriminate in how they educate or treat pupils.

2. Equality law does not dictate what is taught in schools.

3. Respecting people does not require that we have to agree with them. Teaching respect in schools should not include the promotion of particular beliefs or lifestyle choices.

4. Schools must educate, not indoctrinate. State schools have a legal duty to provide education without indoctrinating children or seeking to recruit them to any cause. The state must respect the right of parents to ensure that the education provided is not at odds with their own religious and philosophical convictions.

5. Schools cannot compel thought and expression but should encourage it.

6. A school must not compel a pupil to express their beliefs if the pupil would prefer not to.



WHAT DOES THIS MEAN FOR PARENTS

Parents should:

>>> have direct access to the school, including having someone that they can contact

>>>> know what is happening in the school (e.g., through the school handbook, newsletters, website, social media, parent council minutes, and email communications)

>>> know how to access information readily, as sometimes it may seem as if there is too much information, and it is difficult to know where to begin

>>>> know how to raise concerns and how to withdraw their child from RSHP

know that their rights will be respected (e.g., parents have a right to know what is being taught in each subject and when and supported by which resources - if you have concerns about any aspect of the syllabus, you should contact the school)

HOW TO ACCESS CURRICULUM CONTENT

The school's handbook should give an overview of curriculum content. Detailed information about the Scottish curriculum is available on Education Scotland's website - *education.gov.scot*

If your child is in Senior Phase (S4 – 6), then the curriculum content for the various subjects can be accessed on the SQA website - *sqa.org.uk*

Your individual school will be able to answer any questions you may have about specific curriculum content in any curricular area.

If you have a concern, you should contact the school. A face-to-face meeting with school staff might be beneficial at some stage.
